### GENERAL CONDITIONS

- Candidates having PG in the relevant subjects without NET/SLET/ Ph.D can also apply. However, they will be considered only in case of non-availability of NET/SLET/Ph.D candidates and on a lower salary to be decided by the University.
- The engagement to the posts advertised is purely on short term contract basis and the selected candidates will not have any claim for the permanent appointment.
- Short listing of the applicants, if necessary, shall be made on the basis of higher academic qualification and/or experience.
- The engagement to the posts will be made on the basis of the performance of the candidate in the interview to be conducted by a Committee formed for the purpose.
- The University reserves the right not to fill up all/any of the posts advertised if the circumstances so warrant. Further, the number of candidates to be appointed shall be decided by the University at the time of interviews.
- No TA/DA shall be paid to the candidates for attending the interview. However, the SC/ST candidates will be paid second-class railway/bus fare by shortest route on production of tickets.
- Relaxation of 5% marks (from 55% to 50%) will be provided at the Master's level in the case of SC/ST/Physically Handicapped candidates and to those Ph.D. degree holders, who have passed their Master's Degree prior to 19th September, 1991.
- Applications not accompanied by necessary supporting documents, attested copies of degree certificates/ marks sheets/experience certificate/category certificate (if applicable) issued by the competent authority, shall be rejected summarily.

### **HOW TO APPLY?**

The interviews shall be held on **17<sup>th</sup> March, 2014** at the Transit Campus of the University.
