Notice for Empanelment of Contractors

Notice No. 05 of 2020 Dated: 23.09.2020

Central University of Kashmir intends to empanel the contractors having registration of Class "DEE" & above (Civil/Sanitary & Electrical) registered with the J&K UT Government/CPWD/Railways/PDD or any such other UT/State/ Central Government agency for executing minor Civil/Sanitary, Electrical and other allied repairs/works at CUK campus at Ganderbal for a period of one year.

Eligibility, Guidelines & Last Date

1. Applicants for empanelment should apply in the prescribed form, which along with all other details can be downloaded from CUK's website www.cukashmir.ac.in and CPP portal (<https://eprocure.gov.in/eprocure/app>).
2. The applications dully filled in the prescribed form may be submitted in a sealed cover clearly super scribing "Application for empanelment of contractors" and addressed to Registrar, Central University of Kashmir, Green Campus Ganderbal. Pin: 191201. The rest of the details are given in the prescribed empanelment form. Each page of the application & supporting documents should be signed by the Contractor.
3. If the space in proforma is insufficient for furnishing full details, such information may be supplemented on separate sheet stating therein the part of proforma & serial no.
4. The last date for submission of empanelment document form is **09/10/2020** and the initial date of scrutiny shall be **12.10.2020** at Green Campus Ganderbal.
5. Cost of empanelment documents & processing charges shall be **Rs.1000/-** (non-refundable) in shape of Demand Draft in favour of Central University of Kashmir payable at Ganderbal.
6. Contractors interested in empanelment shall furnish a security deposit of **Rs.50,000/-** in shape of Demand Draft in favour Central University of Kashmir payable at Ganderbal which in case of unsuccessful applicants shall be released subsequently.
7. If a Contractor is applying for more than one category of work, he has to submit separate application along with Demand Draft of Rs.1000/- each.
8. The Contractors will be short listed based on their suitability, experience & other conditions prescribed in the empanelment form.
9. Application containing false & /or incomplete information is liable for rejection. CUK reserves right to accept or reject any or all the applications without assigning any reasons whatsoever & decision of the University shall be final.
10. All other conditions in the GCC & CPWD works manual shall be applicable to contractors selected for empanelment.
11. Contractors earlier empanelled with University shall have to produce a Performance Certificate duly signed by the appropriate University authority.

14.	Contractors earlier empanelled with University shall have to produce a Performance Certificate duly signed by the appropriate University authority.
