**PUBLIC AUCTION NOTICE**

It is notified for the information of General Public that the Central University of Kashmir, Ganderbal is conducting auction of below mentioned condemned vehicles in the premises of its Administrative Campus at Nuner, Ganderbal on 13<sup>th</sup> February, 2019 (11 AM).

**The Terms and Condition of the auction shall be as under:-**

1. The interested bidders shall have to deposit an amount of ₹5,000/= (Rupees Five Thousand Only) as security deposit in the shape of DD favouring “Central University of Kashmir” before participating in the auction proceedings. However, this EMD shall be released / returned after completion of auction process.
2. The auction shall be conducted separately for each vehicle. The successful bidder in whose favour the bid finally closes shall be required to deposit 25% of final bid amount on spot and remaining 75% within 7 days.
3. If the highest bidder/firm fails to honour the bid: the contract shall be cancelled and EMD of the concerned bidder/firm shall be forfeited. In such an event, an opportunity shall be given to the next higher eligible bidder/firm.
4. The bidder/firm must possess the following for consideration of their offer:
  1. Adhar Card/Voter Identity Card/Passport
  2. Registration Certificate in case of firmDocumentary proof of any of the above has to be furnished at the time of auction.
5. The University shall forfeit 25% of the bid amount if the successful bidder fails to deposit 75% of the bid amount within 7 days.
6. If the successful bidder does not lift the auctioned vehicle(s) within 15 days from the date of acceptance of the bid he shall forfeit his/her EMD and deposit.
7. GST or any other Tax, applicable under rules shall have to be paid extra by the successful bidder.
8. In case the date of auction is declared a public holiday the auction shall be held on next succeeding working day.
9. An affidavit regarding purchase of auctioned condemned vehicle/s from the First Class Magistrate shall have to be given, before taking possession of the vehicle/s and letter to this effect shall be sent to Transport Authority.

10. The purchaser shall be responsible for future legal matters whatsoever, pertaining to the vehicle/s after taking delivery.
11. The Auctioned Vehicle(s) shall be handed-over to the successful bidder by Deputy Registrar, Stores Central University of Kashmir once the bidder submits whole bid amount including payment of all taxes applicable to the auctioned vehicles with the University.
12. The successful bidder/s shall also be responsible for getting the Registration Certificate of the vehicle/s transferred in his name at his own cost expeditiously. The Central University of Kashmir shall not be responsible for any lapse on his part in this regard. In this connection the successful bidder/s shall have to submit an affidavit from the First Class Magistrate before taking possession of the vehicle/s.
13. The University shall not be responsible for any damage caused to the auctioned vehicles(s) occurring due to natural calamities like floods, fire, theft etc. in the premises of the University after the auction.
14. The bidder/s desirous of participating in the auction proceedings can inspect the vehicle(s) in the Administrative Campus of the University at Nuner, Ganderbal, on 11<sup>th</sup> / 12<sup>th</sup> February, 2019.
15. The vehicle(s) to be auctioned through public auction, is on 'as is where is' basis and the University shall presume that the interested bidders have inspected the vehicle(s) and satisfied themselves fully about the vehicles which they intend to buy through public auction.
16. The Auction Committee reserves the right of accepting or rejecting any or all bids without assigning any reason thereof and the decision of the Chairman shall be final.
17. Other terms and conditions, if any, shall be announced on the day of auction on the spot.
